As a result of the completion of Rights Issue and partial early redemption of Convertible Bonds with the principal amount of US\$30,000,000 on 18 May 2016, the conversion price of the remaining Convertible Bonds with the outstanding principal amounts of US\$50,000,000 (equivalent to approximately HK\$390 million) has been adjusted from HK\$4.0 per Share to HK\$1.73 per Consolidated Share and the number of outstanding converted Shares has been adjusted from 97,500,000 Shares to 225,433,526 Consolidated Shares. The Convertible Bonds are due for full redemption on 12 May 2020. For details, please refer to the Company's circular dated 10 March 2016 and the Company's announcement dated 17 May 2016.
